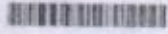



c) The expression "the beneficiary" shall mean any employee as defined above to whom stock units have been granted and any person who is entitled to shares pursuant to any RSU Plan framed by the Settlor.

d) "RSU Plan" shall mean the Settlor's Restricted Stock Unit Plan adopted by the Settlor and amended, or modified or a substituted thereof in future.
