Mphasis announces strategic partnership with quantum software company Classiq

IT-services company Mphasis on Tuesday, June 4, annouced a strategic partnership with Classiq, a quantum software company to commercialise industry solutions powered by Quantum.

In a stock exchange filing, the company said that through the partnership the company aims to accelerate the adoption of quantum computing solutions for enterprises.

The company stated that Classiq has developed a platform for faster and more efficient quantum algorithm design. As a part of the partnership, Mphasis will work on building industry solutions for sectors such as BFSI, Lifesciences, Healthcare, Supply Chain and Logistics, Chemistry using Classiq's platform. The company also mentioned in the release that McKinsey and Company estimates a \$106 billion potential quantum technology market size by 2040.

Mphasis informed the stock exchanges that through its Quantum Initiative, launched in 2020, the company plans to transition its clients towards quantum computing, through an adoption model which comprises awareness-building, assessment, and consulting workshops and other such measures.

Mphasis reported a growth of more than 1% in its consolidated revenue from operations for the March quarter at ₹3,412.1 crore against ₹3,361.2 crore in the same quarter of the preceding fiscal. Sequentially, the company's revenue from operations grew more than 2% from ₹3,337.9 crore in the quarter ended December 2023. The company's revenue from operations decreased nearly 4% to ₹13,279 crore in FY24 compared to ₹13,798 crore in the preceding fiscal.

Mphasis reported a decline of nearly 3% in net profit for the March quarter at ₹393.22 crore compared to ₹405.31 crore in the year-ago period. The company's net profit for the March quarter grew more than 5% from ₹373.6 crore in the quarter ended December. The company's net profit for FY24 declined more than 5% to ₹1,554.8 crore compared to ₹1,637.9 crore in FY23.
